

Catchups - Emergency Disclosure Request

Please note, we need to be able to identify the username of a user for us to retrieve account information. For more information on identifying Usernames, see page 4 of the Law Enforcement Guide. If we receive an Emergency Request Form which does not contain a username, unfortunately we won't be able to locate any information. In that case, we may ask for an updated Emergency Request Form.

Please note: Through our encryption practices, we cannot guarantee that all requests will be fulfilled. We endeavour to work with the relevant authorities to the best of our ability.

Once your Emergency Request Form has been filled out, please email it to us at admin@catchupsapp.com.

Please note, Emergency Request Forms must be submitted by a sworn law enforcement official and must come from an official law enforcement email domain.

We are able to voluntarily disclose information when we believe in good faith that an emergency posing a threat of imminent death or serious bodily injury requires immediate disclosure.

Please review the following steps before submitting this form.

- 1) Please make sure all highlighted sections have been filled in.
- 2) Please make sure the subject line reads "**EMERGENCY DISCLOSURE REQUEST – (your country)**"
- 3) This form must be submitted from your official agency email address.

What is the deadline before which it is necessary to receive this information and/or that suggests there is a specific deadline on which the nature of the emergency will occur (e.g., tonight, tomorrow at noon)

Please explain how the information you are requesting will assist in averting the specified emergency.

I declare that I am a sworn law enforcement official and am making this request as part of an official investigation.

I declare that this request made solely as a result of an emergency involving danger of death or serious physical injury to a person; that this emergency requires disclosure without delay of the information sought above and the information relates directly to the emergency; that that this information shall not be obtained, shared or disseminated for any unlawful or harmful purpose.
